

Foster Care Awareness Primer

A calm, evidence-informed place to begin

Why this exists

Foster care is often discussed through headlines, slogans, and assumptions. This primer offers a humane starting point: what the system is, why it exists, what it cannot be reduced to, and where responsible action begins.

Who it is for

Adults learning about foster care, prospective volunteers or foster parents, employers, churches, book clubs, and community groups.

Your meaningful next step

Visit your state or Tribal child-welfare website and read its official orientation requirements before making a commitment.

What foster care is

Foster care is temporary out-of-home care for children who cannot safely remain in their current home. Depending on the situation, children may live with relatives or fictive kin, licensed foster families, or in group or residential settings. Specific laws and procedures vary by State, Territory, and Tribe.

When children are separated from their parents, safe reunification is generally the priority. When reunification cannot occur, other permanency paths can include guardianship, adoption, or another permanent arrangement.

Foster care is not a single national agency. It is a network of state, local, territorial, Tribal, court, provider, family, and community systems operating under different laws and conditions.

Why children and families encounter the system

Families may encounter child welfare after a report of suspected abuse or neglect or through prevention services intended to strengthen families before a crisis. Neglect is the most common maltreatment category in federal reporting, but poverty alone is not neglect. Concrete supports such as housing, child care, food, transportation, and treatment can strengthen safety and stability.

Language matters

- Say “children or young people in foster care,” not labels that make care their identity.
- Do not assume every biological parent is indifferent or dangerous.
- Do not promise adoption when the goal may be reunification.
- Do not seek private contact with a child outside an approved program.
- Use official state, territorial, or Tribal channels for licensing and placement information.

Common myths

Myth: Every child in foster care is available for adoption.

Reality: Foster care is intended to be temporary, and reunification is often the primary permanency goal. Adoption becomes appropriate only in particular legal circumstances.

Myth: Good intentions are enough.

Reality: Caregivers and volunteers need screening, training, boundaries, trauma-informed support, and continuing accountability.

Myth: Only foster parents can help.

Reality: Communities can mentor through screened programs, support kinship and foster families, provide meals or transportation through approved organizations, advocate for family-friendly workplaces, donate blood, and learn from credible sources.

Myth: A national statistic describes every local community.

Reality: National data show broad patterns; local needs, licensing rules, demographics, and available supports vary significantly.

One responsible path forward

- Learn: read official information before repeating a statistic.
- Locate: find your state, territorial, or Tribal child-welfare agency.
- Attend: join an orientation without treating attendance as a promise to foster.
- Ask: inquire about respite, kinship support, mentoring, CASA, transportation, or practical family needs.
- Reflect: choose a commitment you can sustain.
- Protect: never solicit or publish identifying information about children in care.
